SUBJECT: Health Check/NC Health Choice

On July 20, 2006, you received an Interoffice Communication regarding our new partnership with the NC Division of Public Health and the North Carolina Healthy Start Foundation who jointly promote the availability of free or low-cost health insurance for North Carolina's children. On July 24, 2006, English and Spanish Health Check/NC Health Choice posters were shipped to each local and branch office. In late June or early July, the Raleigh and Greensboro local offices started distributing Health Check/NC Health Choice (HC/NCHC) information. The goal in these two sites has been to integrate the child health insurance message into our service delivery system. From all reports, this has worked well.

We are now ready to begin statewide dissemination of these materials through local and branch offices to assure that families will learn about the state's child health insurance programs. In the next couple of days, a shipment of HC/NCHC information will be mailed to you. Within the next couple of weeks, you will receive a call from a local Health Check Coordinator who does outreach to families in your community. He or she will call and request to schedule a brief orientation to HC/NCHC for your staff. Another excellent resource is the North Carolina Family Health Resource Line where families can call to learn about HC/NCHC and request an application by mail. This is a bilingual line that operates Monday-Friday from 8 am-5 pm.
